It consolidates your audit records from multiple AVEVA™ PI Server installations across the enterprise into a single, searchable interface. With built-in support for electronic signatures, change control tracking, and internal audit logs, it supports compliance with standards such as 21 CFR Part 11, NERC CIP, and ISO while also improving visibility and collaboration across teams.

Use included remote agents to ingest audit records from one or many of your AVEVA™ PI Server installations, including from PI Data Archive and PI Asset Framework servers. Then, review the consolidated records in PI Audit Reporter's unified, web-based interface.

Preserve electronic signatures, user attribution, and comment history with built-in features. Track change control numbers to support traceability with external ITSM/change control systems.

Scalable reporting and review

Use advanced filters to retain and exclude records for streamlined audit data views. Export custom-branded reports in PDF and CSV formats and monitor report generation via the report queue.

Collaborative workspace

Share annotations and comments across teams to streamline validation and review workflows.

Flexible access and security

Enforce role-based access control and integrate with Active Directory and single sign-on (SSO) for secure, enterprise-ready deployment.






Figure 2: AVEVA PI Audit Reporter provides your users with access to all audit data from across your AVEVA PI System.
